b. Approve New Secretary/Treasurer

Because of his workload, JB Leamer has resigned his position as secretary/treasurer but will remain on the board. The Executive Committee is nominating Bill LaLiberte to fill the remainder of Leamer's term, through this year.

c. Approve Returning Blues, Brews & BBQ to First Street Smith (10 min.)

After hearing from numerous merchants who strongly requested that the event be returned to First Street, Smith has talked to almost 50 merchants, City Staff and all City Council members, finding that virtually all support the move.

d. Approve Reserve Policy Language

Pierce (5 min.)

During the February meeting, the board approved of establishing language for a reserve policy, and opening up an account with \$75,000. Here is the language proposed by the Executive Committee:

As a hedge against unforeseen events or circumstances that may impact the ability of the Downtown Napa Association to meet any fiscal year's budget commitments, the board will establish a reserve fund of up to \$150,000. The money will be held in an interest bearing account that can be accessed at any time with the authorization of the Executive Committee and the Full Board.
